Dr. Thomas Coleman arrived half-way through the meeting because another board, of which he is a member, had an open meeting scheduled for the same time.

Motions and Other Business:

1. Vice-Chair Snow called the meeting of the Board of Juvenile Justice to order at 10:07 a.m. on Thursday, January 24, 2013 in the DJJ Board Room located at 3408 Covington Highway, Decatur, GA.
2. A motion to approve the agenda was made, seconded, and approved unanimously.
3. A motion to approve the minutes of the December 17, 2012 meeting was made, seconded, and approved unanimously.
4. Commissioner Niles gave an overview of DJJ's activities since the last Board Meeting.
5. Deputy Commissioner Sarah Draper recognized two employees for exception efforts while off duty assisting with the recapture of escaped youths.
6. After being advised by General Counsel Tracy Masters that the provisions of the Administrative Procedures Act had been satisfied, a motion to adopt an amendment to Board Rule 97-1-.06 Request for Information, so as to update the agency's mailing address, was made, seconded, and approved unanimously.

8. A motion to adjourn the Board of Juvenile Justice and to reconvene as the Juvenile Justice Board of Education was made, seconded, and approved unanimously.
