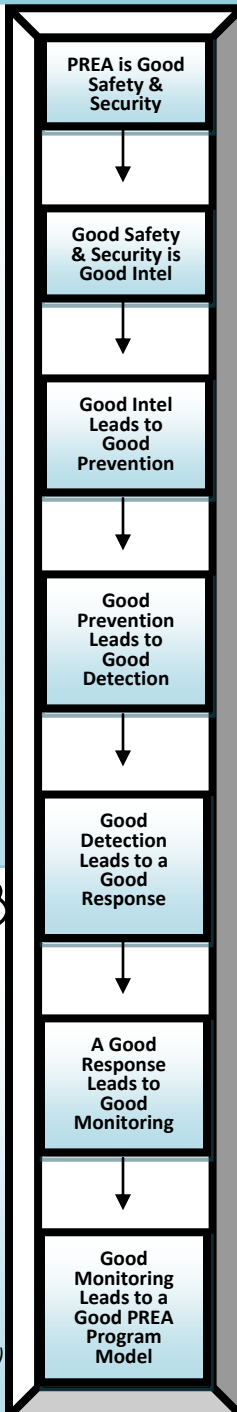
Keep Us Out of the Game!

- PREA Policy (Sexual Abuse and Sexual Harassment)
- Policy Integration (w/Existing Policies /Culture Change)
- Consensual Sexual Relationships are Prohibited (Between youth or between staff and youth)
- Commissioner's Safety/Security Task Force (Facility Infrastructure; Physical Barriers; Blind Spots; Door Locks – Environmental Safety)
 - PREA Facility/Community Point-of-Contact
- Technology (CCTV/Guard Plus/Control Panels)
- Youth Movement (Hands behind Back; Two or more Staff move 16 or more Youth)
- Accommodating Youth w/ Special Needs
- Cross-Gender Viewing and Searches (Same sex pat-down/strip searches; Medical examine Transgender Youth to determine genital status)
- Hire/Promoted/Transferring Staff (Background /Fingerprint Checks)
- Intake Screenings (Sexually Aggressive / Vulnerable Youth Assessment)
- Key Control (Areas where Staff and Youth may interact after hours)
- Youth Placement- (Custody and Housing)
- Specialized & General Staff Training
- Youth Education - RYDC/YDC (Youth Safety Guide)
 - Youth Education - Community (Youth Safety Guide)
 - Public Education - (Brochure for Community/Family)
- Posters /Postcards / Youth Handbook/Intake DVD
- Youth Supervision & Room Checks (Staff ensures that the right youth is in the right room and no other youth has access, youth are not allowed to visit other youth rooms)
- New Contracts or Contract Renewals Comply with PREA
